Transactions that have already been bound may be issued, but no new or expanded coverage(s) may be bound until further notice.

We will continue to monitor this fire activity and will notify you of any modifications to this policy and endorsement binding suspension as warranted by development of the fire. At the appropriate time, we will lift the suspension of your binding authority.
